RESOLUTION NO. 2019-01 AMENDING FISCAL YEAR 2020 BUDGET

WHEREAS Crook County Fair Board adopted the Fiscal Year 2020 Budget in accordance with the Wyoming Uniform Fiscal Procedures Act W.S. 16-4-101 et seq.; and

WHEREAS the Crook County Fair Board discovered that it had insufficient funds carried over from the previous fiscal year to meet the immediate cash flow needs of the Fair Board as indicated on the Fiscal Year 2020 Budget submitted to and approved by the Fair Board on July 9, 2019 and submitted to and approved by the Board of County Commissioners on July 15, 2019; and

WHEREAS the Crook County Fair Board had been incorrectly reporting the cash carryover and anticipated revenues for 3 years due to a change of budget format; and

WHEREAS it was determined by the County Clerk and Fair Board that the Crook County Fair Board needed \$78,000 in addition to other county funds previously appropriated to the County Fair Board to cover the fiscal year 2020 budgeted expenses; and

WHEREAS the Board of County Commissioners appropriated an additional \$78,000 out of the County Emergency Reserve to meet this budget amendment to the Fair Board's Fiscal Year 2020 Budget in accordance with W.S. 16-4-111 and 16-4-113; and

WHEREAS the County Fair Board prepared a proposed amended budget dated October 7, 2019, advertised for one week in the newspapers of the county and held a public hearing on November 4, 2019 at 6:00 PM pursuant to W.S. 16-4-109 to amend the budget; and

WHEREAS, no protests were received regarding such budget amendment.

WHEREAS the Board of County Commissioners have approved the amended Fiscal Year 2020 budget as proposed and will require additional changes to the budgeting process in the upcoming year; and

NOW, THEREFORE, BE IT RESOLVED that the Crook County Fair Board approves the Amended Fiscal Year 2020 budget.
